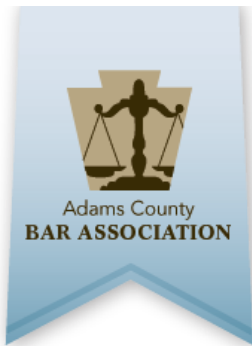


**ADAMS COUNTY BAR ASSOCIATION

**AWARDS:** \$2,500.00 for the first-place winner; \$1,500.00 for second place; and \$500.00 each for up to three honorable mentions.

**ELIGIBILITY:** Students must meet the following requirements:

- 1) Be a graduating senior residing in or attending high school in Adams County;
- 2) Have a "B" grade point average or better;
- 3) Plan on attending a four-year college or university in the fall of 2022;
- 4) Intend to go on to law school or enter a law-related career; and
- 5) Be available to attend an award presentation at the Adams County Courthouse on Friday, April 29, 2022, if selected as a scholarship winner.
